SUMMARY

An Oregon ei Integrated Water Resource Strategy (ei akkot) nge ew anen an ekkewe Oregon state agencies repwe weweiti me tongeni atoura an Oregon ekkewe sokopaten aninis ren konik. Ei Akkot nge ee kan pwan update iteiten nimwu ier. Ina epwe 14 ekkei agencies re kan nounou ei Akkot ren an repwe anganga an Oregon ei konik.

Non ewe spring me summer ren ewe ier 2023, ewe Oregon Water Resource Department (OWRD) ra angang fengen me Oregon's Kitchen Table (OKT), ren ar repwe rong seni aramas non Oregon ren met re mwochen repwe kuna non ei Akkot. Iwe sa rong seni 1900 aramas me non Oregon.

Ei repot aa aporousa met OKT aa rongo seni ewe survey non 9 fosun fenu, ekkewe community conversations ika aporous non ewe community, me pwan ekkewe ekkoch anen an aramas repwe pwan tongeni wau met ekkewe ar ekiek. Met ekkewe aramas ra era iwe sa anomwu non kinikinin ekkewe mi chok pwan nene ngeni.

POROUSEN OREGON'S KITCHEN TABLE

OKT nge ew kinikinin ewe National Policy Consensus Center me Portland State University. OKT aa angang faniten epwe ngeni ekkewe aramas nouwer non ekkewe finata aa fis non public, fen napengeni ekkewe aramas rese kan fen pachenong non ekkei sokkun finata. OKT aa anisi aramas ren ar repwe porousen state, local, me ekkewe osukosukan regional. OKT mi fokkun chomwong anen me non sokopaten fosun fenu an repwe kaeo me sinei met ekkewe aramas ra ekieki me sinei.

Kich mi pwan mwochen ach kei ruu community event repwe fos ngeni aramas.

OWRD, OKT, me pwan ekkewe partners re kan esine ngeni aramas porousen ekkei aporous me survey me won social media, emails, me ekkewe nenien group messaging platforms. Community organizers re kan pwan esine ngeni aramas won fon, text message, ika fos ngenir non foufoun aramas. Community groups me community centers iwe re kan nounou flyers pwan.

Met ekkewe aramas ra etipew won

 - Aramas ra ekieki pwe sisapw chok angang won foforum ennuuk me ennuuk nonmwuch nge sipwe pwan ekieki ach kei osukosuken konik.
 - Napengeni meinisin ir mi kuna nge **ee watte ach kewe need ren konik nap seni an fen kawor.**
 - Chomwong aramas ir mi fosun **epwe or ewe balance.** Aramas re mwochen epwe or ekkewe konik ngeni **aramas me agriculture.** Nge ir mi pwan mwochen epwe or konik non ekkewe rivers me streams ren an epwe tongeni **tumwunu ekkewe iik, maan, ira, me nature.**

 - **Pwaas won fenu** ina ena nampa ew won an aramas ekiek.
 - Aramas ir mi pwan ekieki **ekkewe kaar me pwichikaren ran.** Ir mi pwan noninen ren an epwe or konik non ekkei fansoun. Ir mi ani noninen ika pwe epwe fis ew kaar me pwichikaren ran iwe aa fen ina met epwe sopwei ach osukosuken konik ika pwe aa fen sopweno me apwasano won fenu.
- **Aramas ra mwochen, epwe pwan fateoch porous.**

 - Chomwong aramas ra mwochen **isois konik** non pwisin imwer kewe me ar kewe communities. Re mwochen sinei ifa usun ar repwe tongeni fori.
 - Chomwong aramas ra mwochen ewe state an epwe **aea ekkewe sokopaten anen ar repwe tongeni wau ewe Akkot me tichikin porousen konik.** Sa fokkun pwan rong sokopaten ekiek ren ifa usun an ekkewe state agencies repwe tongeni partner ngeni ekkewe sukun, libraries me museums ar repwe tongeni wau tichikin porousen konik.

- Met ewe mi eucha ngeni aramas ren konik iwe mi watte ewe sokofesen. Ren ekkoch, an aramas need ewe konik iwe ina met epwe akomw. Ren ekkoch, an nature epwe need ewe konik iwe ina fen euchean ren ikkenai me ekkan ran mwaach.
- Aramas rese pwan tipew won **ion epwe wisen fini ifa usun ewe balance ren ekkei sokopaten need**. Ekkoch re mwochen state epwe pwisin fini. Ekkoch re mwochen repwe kuna ewe local government me emon me emon aramas repwe pwisin finata. Iwe ekkoch aramas re mwochen kuna me ruu ewe state me ewe local government ar repwe finata.

FUTURE ENGAGEMENT

Follow Up ren ewe Akkot

Iwe ewe state epwe sopweno me angang won an epwe update ei Akkot non ei fall. Aramas ina repwe pwan mwochen kuna ar kewe input ren ifa usun ar ra aea. Sa mwochen recommend OWRD me ekkewe ekkoch state agencies ar repwe pwan wau ewe draft update ngeni ewe Akkot. Sa pwan mwochen repwe awewei non ar porous ika pwata ra finata ar repwe fori ekkei ekkesiwin. Chomwong aramas ir mi chok kaeo porousan ei Akkot me peirakin kewe. Ami oupwe follow up ren ekkewe aninis ina met epwe tongeni or ewe nukunuk ren ekkewe communities.

Invite ekkewe aramas ar repwe pwan wau met ewe ra ekieki ren peirakin ei Akkot.

Mwirin an Oregon awesi ewe next version ren ewe Akkot, ekkewe 14 state agencies repwe fori ewe pwungun finata ren foforun me ekkewe projects non ewe Akkot. Ei nge epwe pwan or ew fansoun ekkewe state agencies repwe invite ekkewe community members ar repwe pwan fiti an Oregon ewe akkoten konik. Ren awewe chok, chomwong aramas ir mi ekieki eochun konik. Ir mi pwan mwochen sinei porousen pollution me konik mi contaminated. Oregon's Department of Environmental Quality (DEQ) repwe wisen fori ewe pwungun finata won eochun konik. DEQ repwe invite aramas ar repwe wau met ekkewe ra ekieki ren an epwe eochuno konik. Ekkewe aramas ir mi pwapwaiti ar repwe fori ewe pwungun finata ren konik me ekkewe development non ar kewe communities. Oregon's Department

of Land Conservation ir mi tongeni repwe pwan invite ekkewe aramas ren ar repwe fosun ekkewe osukosuk me pwan ekkewe activities repwe tongeni fori fengeni non ekkan ran mwaach.
